MONTHLY SUBSCRIPTION

Subscription fees are invoiced two months after the creation of your account and the placement of your product online on the Chikkii B2B platform. These fees will be charged on the first day of each month, with amounts set at 10 US dollars for DRC vendors, 12 US dollars for Turkey vendors, 12 US dollars for UAE vendors, and 220 RZA for South African vendors.

PERFORMANCE FEES

CHIKKII imposes an incentive fee on sellers, which essentially functions as a commission or percentage of the sales price for each item listed and sold on the CHIKKII platform. This amount represents the payment that sellers pay to CHIKKII for the opportunity to use their platform, connect with customers and promote their products.
